## LINDSAY CRISIS PREGNANCY CENTRE

### STATEMENT OF FAITH

We believe that:

1. The Holy Scriptures as originally given by God are divinely inspired, infallible, entirely trustworthy, and constitute the only supreme authority in all matters of faith and conduct. (2 Timothy 3:16-17; 2 Peter 1:19-21)
2. There is one God, eternally existent in three persons: Father, Son, and Holy Spirit. (Exodus 15:11; Psalm 83:18; Matthew 28:19)
3. Our Lord Jesus Christ is God manifest in the flesh; we affirm His virgin birth, sinless humanity, divine miracles, bodily resurrection, ascension, ongoing mediatorial work, and personal return in power and glory. (Matthew 1:18-25; Hebrews 1:1-3; 1 Thessalonians 4:13-17; Titus 2:13)
4. The salvation of lost and sinful humanity is possible only through the merits of the shed blood of the Lord Jesus Christ, received by faith apart from works, and is characterized by regeneration by the Holy Spirit. (Ephesians 2:8-9; Titus 3:4-7; Acts 4:12)
5. The Holy Spirit enables believers to live a holy life, to witness and work for the Lord Jesus Christ. (Acts 1:8; Romans 8:1-27)
6. The Church, the body of Christ, consists of all true believers. (1 Corinthians 12:1-27; Colossians 1:18)
7. Ultimately God will judge the living and the dead, those who are saved unto the resurrection of life, those who are lost unto the resurrection of damnation. (John 5:28-29; 2 Corinthians 5:10; Revelation 20:15)

### STATEMENT OF PRINCIPLES

1. The Crisis Pregnancy Centre is an outreach ministry of Jesus Christ through His Church. Therefore, the Crisis Pregnancy Centre, embodied in its volunteers, is committed to presenting the gospel of our Lord in word and deed to those with issues related to crisis pregnancies.
2. Commensurate with the above purpose, those who labour as Crisis Pregnancy Centre board members, directors, staff and volunteers are expected to know Christ as their Lord and Saviour. Some non-Christian volunteers may serve at the Centre in non-client contact roles, at the discretion of the Director.
3. The Crisis Pregnancy Centre is committed to providing its clients with accurate educational information about prenatal development, abortion and alternatives to abortion from a Christian perspective.
4. The Crisis Pregnancy Centre is committed to assisting women to carry to term by providing emotional support and practical assistance. Through the provision of God's people and the community at large, women and those involved with them may face the future with hope, and plan constructively for themselves and their babies.
5. In providing services, the Crisis Pregnancy Centre does not discriminate on the basis of race, religion, creed, national origin, age, gender, or lifestyle of its clients.
6. The Crisis Pregnancy Centre is committed to integrity in dealing with clients, earning their trust, and providing promised information and services. The Crisis Pregnancy Centre denounces any form of deception in its corporate advertising or conversation with clients, agencies or other individuals.
7. The Crisis Pregnancy Centre does not recommend, provide or refer for abortion or abortifacients. The Crisis Pregnancy Centre will not intimidate or judge a woman who chooses in favour of abortion, and will treat all clients with honesty, compassion and respect.
8. The Crisis Pregnancy Centre does not recommend, provide or refer single women for contraceptives. (Married couples seeking contraceptive counselling should be referred to their physician or pastor.)
9. The Crisis Pregnancy Centre offers all basic client services free of charge.
10. The Crisis Pregnancy Centre is committed to creating an awareness within the local community of issues related to crisis pregnancies and the sanctity of human life. However, a Crisis Pregnancy Centre will not become involved in political or lobbying activities which do not comply with restrictions established by Revenue Canada.
11. The Crisis Pregnancy Centre recognizes the validity of adoption as one alternative to abortion, but is not biased toward adoption when compared to other life-affirming alternatives.
